- **Signal-to-Noise Ratio (SNR):** Deep space signals are incredibly weak. Solution: Long integration times and cryogenic cooling of detectors to reduce thermal noise.

As we move further into the 21st century, the focus of astronomy is shifting toward **Multi-Messenger Astronomy**. This involves the simultaneous observation of celestial events using both electromagnetic radiation and **gravitational waves**. The detection of a kilonova (the collision of two neutron stars) using both LIGO (gravitational) and traditional telescopes marked a new era in our ability to witness the evolution of the universe in real-time.
