According to **AWWA M57**, determining the correct \$C_d\$ is vital for ensuring that intake structures do not draw in surface-level algae during peak bloom periods. By adjusting the depth of withdrawal based on calculated hydraulic pressures and algal density profiles, engineers can mitigate the intake of cyanotoxins and other metabolites.

Operational Excellence: Valve Inspection, Exercising, and Maintenance

The longevity of a water distribution system is largely dependent on the condition of its valves. Without regular maintenance, valves can seize due to corrosion or mineral buildup, rendering them useless during emergencies like main breaks. AWWA manuals emphasize a systematic approach to **Valve Exercising and Maintenance**.

The Valve Exercising SOP

An effective Standard Operating Procedure (SOP) for valve maintenance includes the following steps:

1. Location and Verification: Utilizing Geographic Information Systems (GIS) to locate the valve box. The physical location must be verified against the asset map.
2. Initial Inspection: Checking the valve box for debris, water accumulation, or structural damage.

5. Torque Monitoring: Using a torque-limiting wrench or automated valve operator to prevent over-torquing, which could snap the stem.
6. Documentation: Recording the number of turns, direction of turn (clockwise vs. counter-clockwise), and final status of the valve (Open/Closed).
