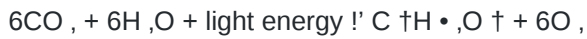

Cellular Energetics: Photosynthesis and Respiration

Biological systems are governed by the laws of thermodynamics. **Cellular Energetics** focuses on how organisms capture, transform, and utilize energy to maintain order. The two primary metabolic pathways covered in Biology II are photosynthesis and cellular respiration.

The Mechanics of Photosynthesis

Photosynthesis occurs in the chloroplasts of photoautotrophs and is divided into two distinct stages: the **Light-Dependent Reactions** and the **Calvin Cycle** (Light-Independent Reactions). The net chemical equation is:



In the light-dependent stage, chlorophyll absorbs photons, exciting electrons that move through an **Electron Transport Chain (ETC)**, ultimately producing ATP and NADPH. During the Calvin Cycle, the enzyme **RuBisCO** facilitates carbon fixation, utilizing the ATP and NADPH to convert CO_2 into glyceraldehyde-3-phosphate (G3P), the precursor to glucose.

The Mechanics of Cellular Respiration

Conversely, cellular respiration is the process by which organisms break down glucose to generate **Adenosine Triphosphate (ATP)**. This occurs in four main stages:

1. Glycolysis: Occurs in the cytosol; breaks glucose into two pyruvate molecules, yielding a net of 2 ATP and 2 NADH.
2. Pyruvate Oxidation: Pyruvate is converted into Acetyl-CoA in the mitochondrial matrix.
3. Citric Acid Cycle (Krebs Cycle): Acetyl-CoA is processed to release CO_2 , generating 2 ATP, 6 NADH, and 2 FADH_2 .
4. Oxidative Phosphorylation: Occurs in the inner mitochondrial membrane. The ETC creates a proton gradient that drives ATP Synthase, producing approximately 26-28 ATP via chemiosmosis.

Ecology and Ecosystem Dynamics

Biogeochemical Cycles

- Carbon Cycle: Driven by photosynthesis and respiration, with significant reservoirs in the atmosphere and oceans.
- Nitrogen Cycle: Relies on Nitrogen Fixation by bacteria to convert atmospheric N₂ into bioavailable forms like ammonium (NH₄⁺) and nitrates (NO₃⁻).
- Phosphorus Cycle: A sedimentary cycle that does not involve an atmospheric phase, primarily moving through weathering of rocks.

Molecular Genetics and Heredity

DNA Replication and Protein Synthesis

Principles of Natural Selection

Natural selection requires four conditions: variation within a population, heritability of traits, overproduction of offspring, and differential reproductive success. Individuals with **favorable adaptations** are more likely to survive and pass their genes to the next generation.

Taxonomic Classification

To organize the diversity of life, biologists use a hierarchical taxonomic system. As organisms move from Domain to Species, they become more closely related. The standard ranks are:

Modern taxonomy relies heavily on **Phylogenetics**, the study of evolutionary relationships. Cladograms are used to visualize these relationships based on shared derived characters (synapomorphies).
