The Geosphere: Composition and Structural Dynamics

The Earth is a differentiated planet, organized into layers based on chemical composition and rheological properties. Understanding the geosphere is essential for biology, as the geological substrate provides the essential minerals and thermal energy required for biological processes. The geosphere is categorized into the crust, mantle, and core, each playing a distinct role in the planet's tectonic and magnetic profile.

Mineralogy and Petrology

The atmosphere is divided into layers: the troposphere, stratosphere, mesosphere, thermosphere, and exosphere. From a biological perspective, the **Stratosphere** is vital due to the ozone layer (O₃), which filters harmful ultraviolet (UV) radiation.

The hydrosphere encompasses all water on Earth, including oceans, glaciers, groundwater, and atmospheric vapor. The unique properties of water—high specific heat capacity, polarity, and density anomalies—stabilize global climates and allow aquatic life to survive in sub-freezing conditions.

Biological Systems: From Cellular Units to Biodiversity

Biology focuses on the study of living organisms, defined by their ability to perform vital functions: nutrition, interaction, and reproduction. The **Cell Theory** serves as the cornerstone of modern biology, stating that all living things are composed of cells, the cell is the basic unit of life, and all cells arise from pre-existing cells.

Prokaryotic vs. Eukaryotic Architecture

The distinction between prokaryotic cells (lacking a defined nucleus, such as bacteria) and eukaryotic cells (possessing membrane-bound organelles, such as animal and plant cells) is fundamental to taxonomy. Technical analysis of cell organelles reveals a complex division of labor:

- Nucleus: Houses genomic DNA and coordinates cellular activity.
- Mitochondria: The site of cellular respiration and ATP production.
