In addition to the ABO group, the **Rh blood group** is determined by a single gene with two alleles (Rh+ and Rh-). The positive allele is dominant, meaning individuals with either Rh+/Rh+ or Rh+/Rh- genotypes will express the Rh-positive phenotype.

3. Molecular Mechanisms of Genetic Disorders

Small changes in the DNA sequence can lead to profound physiological changes. These mutations can occur at the level of a single nucleotide or involve large-scale chromosomal abnormalities.

3.1 Single Gene Mutations
