- **Razor Handling:** Using a high-carbon steel razor maintained at a 45-degree angle to the specimen surface, utilizing a swift, drawing motion toward the body.

The Chemistry of Staining

Staining is not merely a coloring process but a biochemical reaction where specific dyes bind to cellular components based on their pH and chemical affinity. In practical botany, double staining is the gold standard for differentiating lignified and non-lignified tissues.

Taxonomic Analysis of Cryptogams

Phycological Investigations (Algae)

The analysis focuses on the life cycle stages found on the host tissue, such as uredinia, telia, and aecia. Pathological study requires calculating the **Disease Incidence Index (DII)** using the following formula:

$$\text{DII (\%)} = (\text{Number of infected plant units} / \text{Total number of units examined}) \times 100$$

Structural Botany of Higher Plants (Phanerogams)

Floral Formulas and Diagrams

The floral formula is a shorthand symbolic representation of a flower's structure. For example, a typical flower of the Solanaceae family would be represented as:

This denotes an actinomorphic ($\text{''}\bullet\text{''}$), bisexual ($\&\text{¥}$) flower with 5 fused sepals (K), 5 fused petals (C) with 5 epipetalous stamens (A), and a bicarpellary syncarpous superior ovary (G).

Experimental Plant Physiology

Unlike anatomy, which is descriptive, plant physiology is experimental. It seeks to quantify the internal life processes of the plant. Advanced practical work includes the measurement of transpiration rates, photosynthetic oxygen evolution, and enzymatic activity.

Quantitative Analysis of Transpiration

Using Ganong's Potometer, students can measure the rate of transpiration under varying environmental conditions. The process involves measuring the movement of an air bubble in a capillary tube over a fixed time interval. The technical accuracy of this experiment depends on the airtightness of the apparatus, typically achieved using petroleum jelly (Vaseline) at all connection points.

Biochemical Assays: Chlorophyll Estimation

In modern practical botany, the concentration of chlorophyll a and b is determined using spectrophotometry. The Arnon's method is standard, involving extraction in 80% acetone. The concentration is calculated using the absorbance (A) at 645 nm and 663 nm:

- Chlorophyll a (mg/g) = $[12.7(\text{A}_{663}) - 2.69(\text{A}_{645})] \times (\text{V} / 1000 \times \text{W})$
- Chlorophyll b (mg/g) = $[22.9(\text{A}_{645}) - 4.68(\text{A}_{663})] \times (\text{V} / 1000 \times \text{W})$

Where V = final volume of extract and W = fresh weight of the tissue.

Genetics and Biostatistics in Botany

Advanced practical botany integrates quantitative analysis through biostatistics and cytology. These fields allow for the verification of Mendelian inheritance patterns and the study of chromosomal aberrations.

Cytological Preparations

The squash technique is used for studying mitosis in onion root tips. This involves fixing the root tips in Carnoy's fluid, followed by hydrolysis in 1N HCl to soften the cell walls, and finally staining with acetocarmine. Observation under high power (400x or 1000x with oil immersion) allows for the identification of prophase, metaphase, anaphase, and telophase.

Application of Chi-Square (χ^2) Test

In botanical genetics, the Chi-Square test is used to determine if the observed phenotypic ratios deviate significantly from the expected Mendelian ratios. The formula is:

$$\chi^2 = \sum \left[\frac{(\text{Observed} - \text{Expected})^2}{\text{Expected}} \right]$$

If the calculated χ^2 value is less than the table value at a 0.05 probability level, the null hypothesis (that the data follows Mendelian laws) is accepted.

Ecological Sampling Techniques

Practical ecology involves the study of plant communities in their natural habitat. This requires quantitative sampling methods to determine the density, frequency, and abundance of species.

The Quadrat Method

A quadrat (usually a 1m x 1m square frame) is used to sample vegetation. Key ecological metrics include:

- Frequency: $(\text{Number of quadrats in which the species occurred} / \text{Total number of quadrats studied}) \times 100$.
- Density: $\text{Total number of individuals of the species in all quadrats} / \text{Total number of quadrats studied}$.
- Importance Value Index (IVI): A composite metric calculated by summing the relative frequency, relative density, and relative dominance.

Economic Botany and Ethnobiological Documentation

This branch of practical botany focuses on plants utilized by humans. Practical examinations typically involve the identification of plant parts (seeds, fibers, oils, wood) and their taxonomic sources. For example, identifying *Gossypium* (cotton) as a surface fiber derived from the seed coat, or *Triticum aestivum* (wheat) as a caryopsis fruit. Documentation must include the botanical name, family, part used, and active chemical constituents (e.g., alkaloids like caffeine in *Coffea arabica*).

Troubleshooting Common Laboratory Errors

Practical botany is prone to technical errors that can lead to misleading observations. Identifying these early is crucial for accurate data collection.

Issue	Potential Cause	Technical Solution
Air Bubbles in Slide	Improper lowering of the coverslip	Use a needle to lower the coverslip slowly at a 45° angle.
Tissue Plasmolysis	High concentration of mounting medium (e.g., glycerin)	Dilute the mounting medium or use isotonic solutions.
Over-staining	Specimen left in stain for too long	Wash with 70% alcohol (for Safranin) or water to destain.
Opaque Sections	Sections too thick or poorly dehydrated	Ensure thin sectioning; use higher grades of alcohol for dehydration.
