4. Confirmability (Objectivity)

The degree to which the findings are clearly linked to the data and not the researcher's imagination or personal bias.

Modern qualitative research leverages **Computer-Assisted Qualitative Data Analysis Software (CAQDAS)** such as NVivo, ATLAS.ti, or MAXQDA.
