Technical Principles of Detection and Verification

The modern approach to chemical warfare is defined by **Verification Science**. The Organisation for the Prohibition of Chemical Weapons (OPCW) employs various analytical techniques to ensure compliance and detect the presence of prohibited substances in environmental or biomedical samples.
