- **Prosthetic Degradation:** Long shoot days under hot studio lights would often cause latex to melt. This required the development of medical-grade adhesives and cooling systems within the costumes.

As we move into the 21st century, the 101 list expands to include films that utilize **AI-driven VFX** and **Volumetric Capture**. The fundamental principles, however, remain rooted in the works of the early 20th century. The technical mastery of horror lies in its ability to adapt new tools to old fears.

Modern filmmakers now use **Lidar scanning** to create perfect digital twins of environments, allowing for impossible camera movements through solid walls, as seen in recent psychological horrors. This evolution does not replace the practical ingenuity of 1980s body horror; rather, it provides a new set of parameters for the same objective: the technical manipulation of human psychology.
