Visual-Verbal Synergy: The Symbiotic Relationship

The synergy between the tiny car image and the "Think Small" headline created a revolutionary brand identity that defied industry norms.

Failure Case: The Over-Engineered Metaphor

A common failure mode occurs when the conceptual metaphor is too obscure. If a software company uses an image of a deep-sea diver to represent "data immersion," but the copy fails to quickly bridge the gap between diving and database management, the consumer experiences **cognitive friction**. The result is a high bounce rate and low brand recall. This illustrates Felton's warning: never let the art get in the way of the message.

Practical Implementation: A Field Guide for Copywriters

To implement the principles found in *Advertising: Concept and Copy*, professionals should follow a strict technical checklist for every creative deliverable:

1. Identify the Key Insight: What is the one thing the consumer doesn't realize they need?
2. Draft 50 Headlines: The first 20 are usually clichés. The next 20 are variations. The final 10 are where the breakthrough concepts reside.
