Core Technical Components: Slings, Hitches, and Hardware

The selection of rigging hardware is the first critical step in any lifting operation. Slings are generally categorized by their material composition, including **synthetic web slings**, **wire rope slings**, and **alloy steel chain slings**.

Synthetic Web Slings

Synthetic slings are favored for their flexibility and ability to handle delicate loads without marring the surface. However, they are highly susceptible to environmental damage, such as UV exposure and chemical degradation. Riggers must inspect these for cuts, snags, and melted fibers before every lift.

Wire Rope Slings

Wire rope consists of individual wires twisted into strands, which are then laid around a core. The **6x19** and **6x37** classifications are common in rigging. Wire rope offers a high strength-to-weight ratio and is more resistant to

heat and abrasion than synthetic materials. However, its capacity is significantly affected by the **D/d ratio**(the ratio of the diameter of the object the rope is wrapped around to the diameter of the rope itself).

Mechanical Hitches

How a sling is attached to a load determines its lifting capacity. The three primary hitches taught in the **NCCER Basic Rigger** curriculum are:

- Vertical Hitch: The sling is attached directly to the load and the hook. The full rated capacity of the sling is available.
- Choker Hitch: The sling passes around the load and attaches back to itself. This reduces the capacity by approximately 20-25% due to the stress at the choke point.
- Basket Hitch: The sling passes under the load with both ends attached to the hook. This effectively doubles the capacity, provided the legs remain vertical.

The Mathematical Principles of Sling Tension

One of the most critical aspects of the **NCCER Level 1** training is the calculation of **sling angles**. As the angle between the sling and the horizontal plane decreases, the tension on the sling increases exponentially. This is a concept often misunderstood by novice riggers, leading to catastrophic failures.

Calculating the Sling Angle Factor (SAF)

The tension on a sling is calculated using the formula: **Tension = (Load Weight / Number of Slings) x Sling Angle Factor**. The Sling Angle Factor is the ratio of the sling length (L) to the vertical height (H). For example, if a rigger is using a 10-foot sling to lift a load where the vertical distance from the hook to the load attachment point is 5 feet, the SAF is 2.0 (10/5). This means the tension on the sling is twice the actual weight being lifted by that specific leg.

Horizontal Angle (Degrees)	Sling Angle Factor (L/H)	Percentage of Load Increase
90° (Vertical)	1.000	0%
60°	1.155	15.5%
45°	1.414	41.4%
30°	2.000	100.0%

As shown in the table above, lifting at a 30-degree angle doubles the stress on the rigging hardware. The **Basic Rigger Level 1 Trainee Guide** emphasizes that rigging at angles less than 30 degrees is generally discouraged and often requires a professional engineer's approval.

Mechanical Advantage: Jacks, Hoists, and Tuggers

Ratchet-Lever Hoists (Come-Alongs)

Common Rigging Hazards

- Pinch Points: Areas where a body part can be caught between the sling and the load or between the load and a stationary object.
- Electrical Hazards: Maintaining minimum clearance distances from power lines (typically 10 to 20 feet depending on voltage) is critical to prevent electrocution.
- Load Instability: Failure to identify the Center of Gravity (COG) will cause the load to tilt or swing when lifted,

potentially snagging other structures or tipping the crane.

- **Equipment Fatigue:** Recognizing the signs of wear, such as "bird-caging" in wire rope or "kinking" in chains.

The Inspection Checklist

A Level 1 rigger is often tasked with the daily inspection of rigging gear. This process must be documented and follow **ASME B30.9** standards. Any piece of equipment that does not meet the inspection criteria must be removed from service and destroyed to prevent accidental reuse.

Establish a clear line of communication with the crane operator. Use standard **ASME hand signals** or radio communication. The rigger must remain in the operator's line of sight unless a designated signal person is used. During the "initial lift," raise the load only a few inches to verify the balance and the integrity of the rigging.

Troubleshooting Common Rigging Failures

Even with thorough training, challenges arise in the field. Understanding failure modes is key to preventing them.

- Problem: The load tilts during the lift. Solution: The hook is not over the COG. Lower the load and adjust the

sling lengths or move the hook. Do not attempt to pull the load into balance manually.

- Problem: A sling is pinched under the load. Solution: Use wooden blocking or "softeners" to create a gap between the load and the floor. This protects the sling from being crushed and facilitates its removal.
- Problem: High winds cause the load to spin. Solution: Use taglines. A tagline is a non-conductive rope attached to the load that allows riggers to control rotation from a safe distance.
