### The Streeter-Phelps Model for Dissolved Oxygen

One of the most famous applications of environmental problem-solving is the **Streeter-Phelps equation**, used to predict the Dissolved Oxygen (DO) sag curve in a river following the discharge of biodegradable waste. The model balances two competing processes: **Deoxygenation** (due to microbial consumption of organic matter) and **Reaeration** (the absorption of oxygen from the atmosphere).

The DO deficit (D) at any time (t) is calculated as:

## Atmospheric Science: Dispersion Modeling and Air Quality

A 'Class A' atmosphere is highly unstable (convective), leading to rapid dispersion, while 'Class F' is stable (inversion), leading to poor dispersion and higher ground-level concentrations.

## Solid and Hazardous Waste Management

Modern waste management has shifted from simple disposal to **Integrated Waste Management**. This involves analyzing the lifecycle of waste from generation to final sequestration or resource recovery.
