2. Contextualization through Example Sentences

The dictionary provides authentic example sentences for each entry. For **Hanzi (Chinese Characters)** acquisition, it is insufficient to learn the word in isolation. The technical learner should import the word, its frequency rank, its pinyin, and its primary example sentence into a flashcard database.

3. The "95% Coverage" Strategy

To achieve **Extensive Reading** capabilities (reading without a dictionary), one needs to understand roughly 95% of the tokens on a page. By mastering the 5,000 words outlined in the Routledge frequency list, a learner reaches this threshold for most non-technical newspapers and novels.

Case Study: The Challenge of Multi-Character Words
